Preamble to privacy

The sponsorship project "Amy Carmichel - Help for Children in India" (Amy Project), Amy Foundation (India) is a child relief project. The aim and purpose is to enable poor girls in southern India to complete a school or vocational education or study. The foundation is a foundation that consists of the foundation's capital, and the patentee (Amy-Paten).

The Amy project is available in Germany via Mr. Winfried Stelle. He is a volunteer project coordinator. The email address is amy.carmichel@web.de. The address of the Amy Project is "Amy Carmichel", c / o Winfried Stelle, Hetzboldstr. 17, 99631 Weissensee.

Processing and use of data

We only collect, process, use and store personal data insofar as this is necessary for our direct work.

The website of the Amy Project www.amycarmichel.bplaced.net serves as information only about our project work and partly also provides background information on India, the mission history and facts that are connected with it. Personal data will not be collected and / or passed on through them.

Every two months, the newsletter of the Amy project is published. It is also a pure information medium and is part of the Amy website. In addition, all Amy sponsors receive it by email, if there is no email address, by post.

Donors without a sponsorship or interested people can also apply for the newsletter via email at amy.carmichel@web.de.

To receive the newsletter, the specification, storage and use of the email address or postal delivery of the address of the user is required, otherwise a delivery is impossible. The data of the newsletter distributor are used solely for this purpose.

For sponsors and other interested people, who want to receive up-to-date information about our project work beyond the newsletter, there is a WhatsApp group. This is from our side also a pure information medium. Admission to the group is only on request.

Our girls in India are supported by personal sponsorships. This only works if contact with each other is possible. For this reason the godparents receive a staff questionnaire with the most important information about their godchild, the cooperation partner in India (for the girls) name and address of the godparents. A notification is also made on the amount of the sponsorship contributions.

The foster-parents must, in order for a foster-parent-ship to be made possible, make a sponsorship application. In addition to name, address, telephone number and e-mail, the amount of the planned sponsorship fee is also queried, as well as whether an annual donation receipt is desired.

The Amy project uses the data collected in the application only for the purposes necessary for the sponsorship: information of the individual mentors and queries, contact with the godchildren, issue of annual donation certificates.

For donors without a foster-parent-ship, who would like to receive an annual donation, there is also the need to store the name and address, as otherwise it would be impossible to issue and deliver the certificates.

Account information is generally not collected by the Amy project! - The foster-parents and donors are required to transfer their contributions and donations on their own account to the relevant project account.

The Amy project is just a small private initiative, not an association. For this reason, we cooperate with the Evangelical Parish Weissensee / Thür in relation to the issue of donation records. In order to be able to draw up the certificates in question, it is necessary to pass on the name, address and amount of the donations (for this purpose only) to them. The legally required storage periods are observed.

The foster-parents / donors may at any time receive written information about the data stored regarding their person and demand correction if the stored data are incorrect. If the stored data is not or no longer necessary, then the godfather / donor can also request a blocking, possibly also a deletion of the personal data.

Further information on data protection

A further transmission of the data does not take place or only if you have expressly consented to the transmission. A transfer of your data to third parties without explicit consent, such as for advertising purposes, does not occur.

Please note that data transmission over the Internet (for example, when communicating via email) may have security vulnerabilities. A complete protection of the data from access by third parties is not possible.

The use of contact data published in the context of the imprint obligation by third parties for sending unsolicited advertising and information materials is hereby expressly excluded. The operators of the pages expressly reserve the right to take legal action in the event of the unsolicited sending of advertising information, such as spam e-mails.

Consent and contradiction

The data protection preamble applies with publication on the website of the Amy project / the entry into force of the new data protection law of the European Union on 25.05.2018.

Opposition is possible until 3 weeks after publication in the Amy Newsletter June / July 2018 (06.06.2018). If no objection occurs within the specified period, this shall be deemed approval.
